



REGULATIONS FOR OAKWOOD EAST CEMETERY

- 1. The cemetery and all lots therein shall be used for no other purpose whatever except as a burial place for the dead, and no conveyance of a lot, or part of a lot, shall, in the absence of an express grant, carry any right, title or interest in abutting streets or alleys except an easement or right-of-way thereover.**
- 2. In order to secure the observance of health laws of the State of Virginia or of the United States, that now are or may hereafter be enacted, and to preserve a record for the identification of persons whose bodies may be buried in the said cemetery, no burial shall take place in the said cemetery, and no body buried therein shall be removed therefrom, except those that may first be reported in writing by the owner of the lot, in which that burial, or from which that removal is desired, to the proprietors of the said cemetery or their agent, with a specification of the name (if known), place of birth (if known), age (if known), cause of death (if known and required by law) and place of death in writing provided, that the permits shall be issued without pecuniary profit to the proprietors, their officers, agents or employees. The term proprietors as used herein shall be taken to mean the TOWN OF PULASKI or by judicial sale, shall be vested with the rights described or mentioned in this deed as belonging to or exercised by the proprietors.**
- 3. No grave shall be located less than six (6) inches from the boundary of the lot in which the grave is placed.**
- 4. No grave vault shall be erected that does not conform to the requirements of the proprietors, as to material, workmanship, depth of excavation and relation to the surface of the ground.**
- 5. No monuments or grave marks shall be erected except those of marble or durable stone and must be flush with the ground.**
- 6. No improvements or enclosures shall be made in such a manner as to leave the premises in disorder. No wooden enclosures, wire arbors or signs of any kind, shall be placed upon any lot.**
- 7. No hedges or trees shall be planted on any lot, nor shall any growing tree thereon be removed without the consent of the proprietors of the said cemetery. If any trees or shrubs in lots shall become unsightly or detrimental by their roots, branches or otherwise, to adjacent lots, walks or roads, the proprietors of the cemetery shall have the right to remove them. No plants, shrubs or other foreign vegetation shall be permanently placed on or near the space.**
- 8. The grade lines fixed, or to be fixed from time to time by the proprietors of the cemetery, shall be strictly observed in the grading of lots, and no lot shall be graded in violation thereof.**
- 9. The proprietors of the cemetery shall have the right to make and enforce whatever rules may seem to them proper, for the regulation of admission to the said cemetery and the conduct of visitors, and for the preservation of the sacredness of the place.**

- 10. The right of sepulture hereby granted shall no be transferred without the consent of the proprietors of the cemetery first obtained in writing.**
- 11. The cost of each grave space is \$600.00 and is subject to an adjustment by the cemetery Trustees when it is determined what cost is necessary to operate the cemetery.**
- 12. The cost of the space is to include perpetual care.**

NOTE: As of 01/05/2016 the price of a grave spaces were increase to \$600.00
